- 1) Call to order at 7:08 p.m. Welcome from Rick Wagener, president.
 - a) There is no planned increase for our annual dues. 2011 was a mild year for us with no major unanticipated costs. Thanks for Edna, Warren and Mark for doing a great job paying the bills and taking care of the financials.
 - b) The park cleanup day went very well thanks to all of those who came down to help. We need to repair the breaker on the pond pump, but the pond is looking great due to Warren's efforts.
 - c) Thanks to Amy Bunch for volunteering as our dedicated newsletter editor.
- 2) Introduction of board members in attendance: Rick Wagener, Warren DeWitt, Tiffany Fronek, Edna Coghlan, Tom Greaves, Herb von Rusten, Mark Bunch, and Dan Lewis.
- 3) A sign-in roster was distributed and each attendee introduced him/herself, often saying how long they have lived in Rochdale. Many residents commented about how much they love our neighborhood.
- 4) Treasurer's Report: Board Treasurer Edna Coghlan distributed the Treasurer's Report and discussed the revenues and expenses through the past calendar year. 94 of 108 total annual dues were collected. Postage and office supply costs increased to \$347.03 because we now mail out the annual dues invoices. We now get our bank statements online to save the \$5 monthly bank fee. Clarence Vos moved to accept the financials as is & Rick Wagener seconded.

 - c) B. David Grice & Jo Ann Bourez dicussed our sub's history.
 - d) Jo Ann Bourez wondered if we planned to read last year's minutes into the record. Tiffany apologized for not knowing this needed to be done as it wasn't on the agenda. Tiffany will ask Mike Wood to post both this year's and last year's minutes onto our new website.
 - e) Mike Wood is constructing a new website as our old web host is defunct. The website address www.rochdalesub.com will remain the same. He anticipates being finished by the end of June.
 - f) Steve Chapman, son of member Ann Chapman, expressed his displeasure with the board's handling of both finances and the upkeep of the park pond. He requested copies of financial records and the by laws. Rick Wagener said he's happy to look into this and will respond to Ann Chapman in writing promptly.
